IBT LU 760 PLAN SUMMARY

FOR ELECTION OF DELEGATES AND ALTERNATE DELEGATES TO THE IBT CONVENTION

IBT LU 760 is entitled to elect 6 delegates and has chosen to elect 2 alternate delegate(s) to the June 2016 IBT International Convention. The expenses of the delegate(s) 6 and alternate delegate(s) 2 will be paid by the IBT LU 760. The Election Supervisor has approved the IBT LU 760's plan for conducting nominations and elections. The important details of the plan are summarized below. This summary must remain posted until 30 days after the date of posting of the names of the elected delegates and alternates, whether chosen by white ballot or as a result of a contested election.

NOMINATION	
Where:	1211 W Lincoln Ave., Yakima, WA 98902
When:	Thursday, August 20, 2015 at 7:00 pm
Who Can Attend:	Any active member may attend any meeting.
Who Can Run:	A member must be in continuous good standing for a period of twenty-four months prior to the month of August 2015. Seasonal workers in the food industry will be eligible to nominate and second provided (1) they were in regular employment during some period of the twelve (12) months prior to the election and (2) paid their dues through the last month of employment.
Who Can Nominate:	Members in good standing (full dues paid through July 2015) may nominate or second the nomination of a candidate or slate of candidates.
Nominations:	Nominations may be made or seconded orally at the nomination meeting or submitted in writing, including the signature and last four digits of the nominator's or seconder's SSN/SIN, to the Secretary-Treasurer not later than 5:00 p.m. of the day immediately prior to the meeting.
Candidate Acceptance:	A member may accept nomination in person, or if absent from the meeting, by furnishing a written acceptance, including the signature and last four digits of the candidate's SSN/SIN, to the presiding IBT LU 760 officer no later than the time the member is nominated.
Eligibility Deadline:	Dues must be paid at Teamsters Local No. 760 1211 W Lincoln Ave. Yakima, WA 98902, at 5:00 PM on August 20, 2015.
Additional Info:	The IBT LU 760 will send a Nominations Notice to all members with additional instructions for participating in the nominations process.

Mail Balloting:	All members should receive a ballot at their home address before October 1, 2015. Any member not receiving a ballot by that date should request a ballot by calling the IBT LU 760.
Voting Deadline:	VOTED BALLOT MUST BE RETURNED BY MAIL IN TIME FOR RECEIPT NO LATER THAN 9:00 A.M. on October 16, 2015
Eligibility Deadline:	Dues must be paid at Teamsters Local No. 760 1211 W Lincoln Ave. Yakima, WA 98902, before 5:00 PM on October 15, 2015.
